- Document accurately and in a timely manner according to CNO standards
- Delegate/teach and oversee skills and techniques to other staff/residents and/or families as required
- Complete medication orders and quarterly reviews
- Conduct and attend post admission and annual care conferences
- Assist with Quality Improvement by conducting audits as assigned
- Report and complete medication error forms and initial follow up
- · Attend team meetings as required
- Provide feedback on staff performance
- Assist with writing and updating policies and procedures
