## **NOTICE TO FAMILIES OF RESIDENTS**

### **New Visitation Restrictions and Testing Requirements in place to reflect Code Orange-Restrict status**

As you may be aware, the provincial government recently created a colour coded system for identifying the degree of COVID-19 risk in any given area of Ontario, with specific measures put in place for each risk level.

In accordance with regulations set out by the Ministry of Long-Term Care for Code Orange - Restrict protocols, the following visitation restrictions are now in place at St. Joseph's Long-Term Care:

- **Inside visitation is restricted to one essential caregiver. Residents may have two designated essential caregivers however, only one may visit at a time, effective immediately.**

**NEW TESTING REQUIREMENTS: Effective immediately, essential caregivers must now be tested weekly, as directed by the Ministry of Long-Term Care. Beginning Monday, November 30, essential caregivers must provide proof of a negative test result on a weekly basis.**

**Essential caregivers who are visiting LTC before November 30 will be required to show proof of a negative test result from your test taken during the previous 14 days.**

- **No other inside visitation is permitted at this time.**
- **Short-stay and temporary absences are currently suspended**

To help our residents remain connected with their loved ones, our staff is currently making arrangements with family members to convert all other scheduled inside visits to virtual and window visits.

**Staff testing.**

To further prevent virus spread, the Ministry of Long-Term Care now requires all staff of Long-Term Care homes to be tested weekly. Proof of a negative test result must be provided on a weekly basis.

**Colour codes can change.** As the number of COVID-19 cases increase or decrease in our area, the colour code may change accordingly. When a colour code changes, St. Joseph's Lifecare Centre may revise our COVID-19 protocols to reflect this, and updated information will be posted on the [COVID-19 page](#) of our website. We strongly recommend you check the [COVID-19 page](#) of our website at least once daily for the most up-to-date information. All documents are listed by the date of publication with the most recent information appearing at the top of the list.

***Important notice to families of residents:** we all play a vital role in controlling the spread of the COVID-19 virus and bringing the pandemic to an end. It is important to recognize that all infection-control measures we introduce are mandatory, as directed by the Ministry of Long-Term Care. We are required by law to implement and enforce these measures for the protection of everyone who resides, works or visits here. The absolute intention of these measures is to save lives.*

*Families are key members of our COVID-19 prevention team. Your co-operation and understanding are vital to the safe operation of our Home and the well-being of your loved ones who reside here. I highly recommend you take every opportunity to connect with your loved ones using the safe methods of communication that are available to you.*

The good news is that a vaccine is expected to be available in a few months. Until then, we must do everything we can to control the spread of this deadly virus, especially now, when the rate of COVID-19 transmissions in Ontario is higher than ever.*
